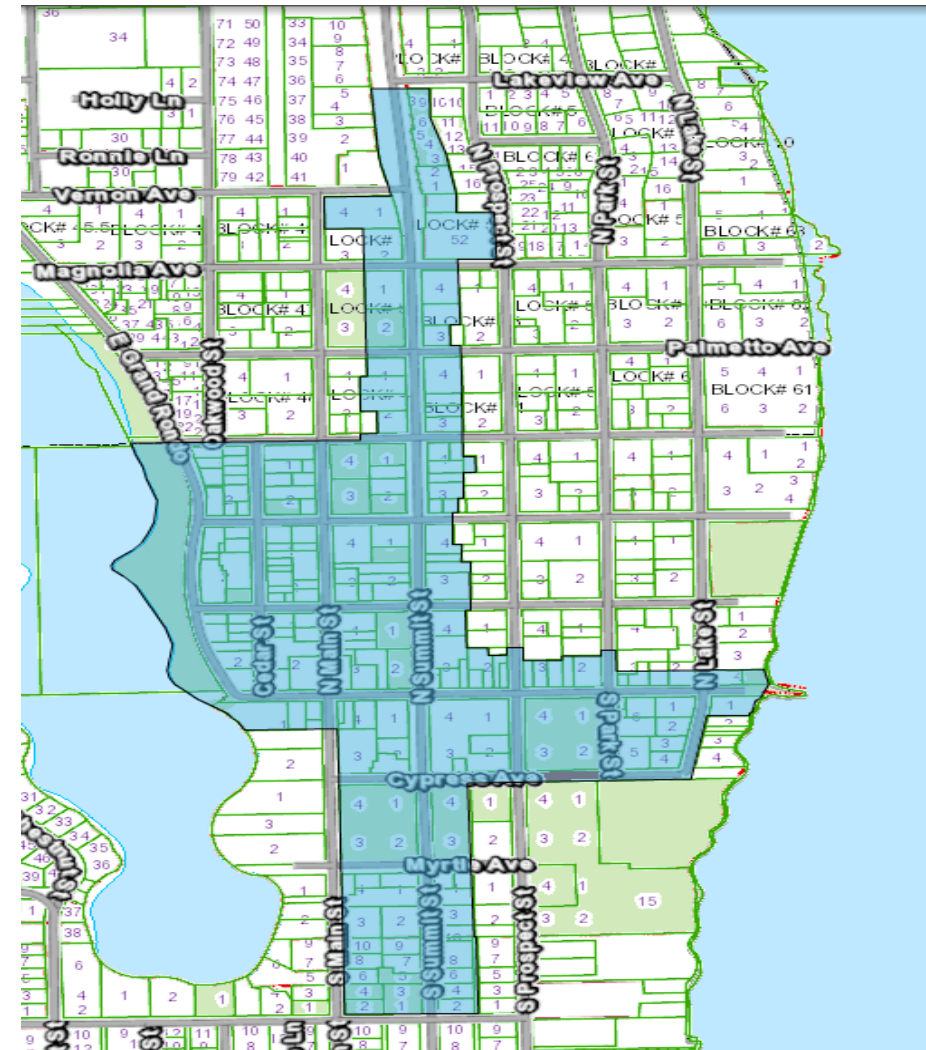

\* The slower growth inside the existing CRA is primarily the result of the decline in value of the "Miller Property". In 1995 the property was intact and valued at \$769,074, or roughly 10% of the total assessed value inside the CRA. By 2010 the market value dropped 25% because it was vacant and the very definition of blight and slum property, but it was already assessed at \$0 because it had been seized by the Federal Marshalls office years earlier. Once purchased by the City for clean up, the assessed value remains at \$0. Thus, 10% of the 1995 value remains lost until redevelopment occurs. Additionally, outside the CRA we saw the construction of the Winn Dixie.
