To obtain your license, please complete the enclosed application form and return it to our office, together with your remittance and any applicable photocopies as listed below. Please note a Business Tax Receipt will not be considered complete and you will be operating in violation of (Section 12-1 of the City Code) if required information is not submitted. If further information is requested, please contact City Hall at (386) 698-2525, Ext 229.

LICENSE FEES

Business Tax Receipt \$ 36.75 Peddler License - \$200.00 - Per Selling Unit Vending Machines, Amusement Machines, or Coin Operated Vending \$10.00

EXEMPTIONS FROM FEE (Proof Required) \$ 7.50 per unit

- 1. Disabled Persons Physically Incapable of Manual Labor with not more than 1 employee or helper and who use their own capital only not more than \$1,000.00.
- 2. Widows with Minor Dependents with not more than 1 employee or helper and who use their own capital only not more than \$1,000.00
- 3. Persons 65 Years of Age or Older with not more than 1 employee or helper and who use their own capital only not more than \$1,000.00
- 4. Disabled Veterans of War
- 5. Contractors with State Registration and/or Certification

New Business Checklist

ZONING To determine if the location and/or building conforms to zoning ordinances for the type of business contemplated, check with the City Planning & Zoning Department at 3 N. Summit Street, Crescent City, FL (386) 698-2525. Businesses operating from a residence require a Home Occupational Permit which can be obtained from the Planning & Zoning Department.

FEDERAL To obtain a Federal I.D. Number, you must contact Internal Revenue Service at 800-829-4933 or www.irs.gov

FICTITIOUS NAME A current copy of the business Fictitious Name Registration is required in order to receive a Business Tax Receipt unless the business uses its corporate name as stated in its Articles of Incorporation, a sole proprietor using their legal first and last name as it appears on their driver's license, an individual attorney doing business in his legal name as a professional association or a business licensed by the Department of Business and Professional Regulation that is doing business in the name as it appears on the state license. HOTEL, MOTELS, & RESTAURANT Contact the Division of Hotels and Restaurants at 1-850-487-1395 prior to obtaining your Business Tax Receipt.

MOTOR VEHICLE REPAIR Contact the Department of Agriculture & Consumer Services at 1-800-435-7352 to obtain your Motor Vehicle Repair Registration. Also required is clearance from Environmental Health in Palatka, Fl. (386) 326-3267

DEPARTMENT OF AGRICULTURE Anyone selling food (Convenience store, grocery store, bakery, ice cream parlor, sandwich truck, fish or meat market, food warehouse, etc.) needs to call the Department of Agriculture at (850) 488-3951 for an inspection/state license.

WASTE HAULERS AGREEMENT Commercial Operators located in Crescent City are required to have a Contract with a Licensed and insured Waste Hauler prior to commencing operations.
