from world-class crappie and bass fishing to kayaking, swimming, and taking in the abundant wildlife.


The city is 24 miles southeast of Palatka, Florida and 48 miles northwest of Daytona Beach. It has a total area of about 2.1 square miles and has a friendly small-town atmosphere. The city is culturally diverse with significant Latino and African American populations. The most recent population estimate was 1,702.

## History

Crescent City has a long and fascinating history that dates to the 19th century when it was first settled by pioneers. The town grew rapidly in the late 1800s thanks to the citrus industry as well as post-Civil War migration and tourism, which brought in a great deal of prosperity and led to the construction of many of the town's historic buildings and homes.

Crescent City has a National Register Historic District, designated in 1997 that includes nearly 200 historic sites and structures, dating between the 1880's and the 1940's. Over 20 commerical buildings are in the core of the city's historic business district, and other structures include homes and churches. Styles represented include Frame and Masonry Vernacular, Gothic Revival, Prarie, Craftsman, Italianate, Italian Renaissance and Romanesque Revival.

## City Government

Crescent City was incorporated in 1885. The City Commission is made up of 5 members; 4 commissioners and the mayor-commissioner-all of whom are elected at-large for 4-year terms. They are seeking a manager who is a self-starter that can serve in a unique city that includes 21 full-time employees. The City Manager also serves as the Executive Director of the Community Redevelopment Agency (CRA). An Assistant City Manager provides management support to the City Manager while providing an oversight of community redevelopment activities.

The Manager serves at the pleasure of the City Commission for an indefinite term, subject to termination at any time upon a three-fifths vote of the full commission.

The City Manager directs and supervises the administration of all city departments and agencies. He/she recommends to the City Commission the appointment and, when necessary, the removal of directors and employees, except as otherwise provided by the City Charter or rules in the personnel ordinance. He/she is responsible to the City Commission for the

implementation of the Commission's policies and procedures. The City Manager has oversight of all city departments including Planning, Community Redevelopment, Public Works, Water, Sewer and Gas Utilities, Finance, Fire Rescue, Parks and Recreation, and Utility Billing. Law Enforcement is contracted to the Putnam County Sheriff's Office. The Building Department permit review & inspection is contracted to Putnam County. The city uses consulting firms for Planning and Zoning, and IT.

Crescent City has a Main Street program in its third year in Apprentice Status. Main Street program rules require the City to provide financial support, and the City, CRA and Main Street program must coordinate to achieve mutual goals.

### Qualifications

The Manager is required to have a bachelor's degree from an accredited college. Course work in Public Administration, Business Administration, or City Planning is preferred. Five years of work experience in public administration is a minimum requirement. An equal amount of work experience in the public or private sector in management with an entity of similar size and complexity to Crescent City may be considered a functional equivalent.

The successful candidate must wear many hats. They will be expected to become part of the community and get involved in civic clubs or other organizations. Major challenges the new City Manager will face include providing stable leadership not just to manage but to move the city forward. Implementing strategic goals and modernizing financial procedures will be important. There are also several community challenges, especially in the areas of recruiting new businesses, historic preservation, and code enforcement to upgrade or remove blighted buildings. Major projects will require the ability to obtain and manage grants or legislative appropriations to obtain an unused school and convert it to a City Hall and Community Center, refurbish a recently acquired historic masonic lodge, and implement the construction of several water and sewer projects.

## **About Crescent City**

**Education:** K-12 Schools for South Putnam are in, or just adjacent to Crescent City. Crescent City Jr. -Sr. High School is just outside of town, and a new building is currently being constructed on the property. A new Elementary/ Middle School is also under construction on newly-annexed property on the north side of town, near the Jr-Sr High School. These schools both offer the Cambridge/ AICE (Advanced International Certificate of Education) programs, beginning in elementary school. High school students have access to both AP classes and dual enrollment at St. Johns River State College (SJRSC) in Palatka. The District offers significant vocational-technical and STEM programs. Nearby colleges are SJRSC, Daytona State College, Enbry-Riddle University and Bethune-Cookman Colege in Daytona Beach, Stetson University in Deland and Flagler College in St. Augustine. There is a significant Home School population in Crescent City and the surrounding areas.

**Businesses and Shopping**: Crescent City is a commercial and service center for the South Putnam and Northern Volusia areas. Major businesses/ employeers in Crescent City include the School District, St. John's Recovery Place, a respected rehabilitation facility that is expanding, a nursing home, and the Winn Dixie grocery store.

Shopping and services include-Full service U.S. Post Office, South State Bank and a credit union; Dollar General and Family Dollar stores, convenience stores, two gas stations, an independent pharmacy, a computer repair/consulting business, two laundrymats, UPS and Federal Express outlets, several auto repair and tire shops, an auto detailing business, and ACE Hardware store and lumber yard, a Cricket cellphone store, and a number of restaurants, both family owned and fast food. There are several physician's offices, a full-service physical therapy provider and local veterinary clinic. There is a branch of the Putnam County Library in Crescent City, and a Government Services Annex for the Clerk of Court and Tax Collector Services. Additional shopping and restaurants are available in Palatka, Deland and Daytona, including major chain stores such as Home Depot and Lowes.

Recreation, Civic Organizations and Churches: Crescent City has a number of parks and walking paths, two pickle ball courts, two shuffleboard courts, a tennis court, a soccer field and baseball field, baskeball, and several children's play areas. There are three boat ramps available free of charge, two on Crescent Lake and one on Lake Stella. There is a swim beach and kayak launch on Lake Stella, and a dog park on Crescent Lake. County sports fields and recreation programs for children are just north of town. Private dance and other classes are available downtown, and in other areas. There is a local private gym. South Putman Church offers some sports and recreational programs, especially for children. The Dunn's Creek State Park and Welaka State Forest are nearby, and DeLeon Springs and Ravine Gardens are not too far away. There are a number of churches in the area, both major denominations and independent. Civic organizations include the Rotary Club of Crescent City, Crescent City Woman's Club, the Crescent City Yacht Club (no building or marina), and the Fruitland Peninsula Historical Society.
